

# HealthTech Investor Day will focus on drawing investments to European companies and on the latest medical innovations

Meetings between European HealthTech leaders, international investors and pharmaceutical groups to be held in Paris on June 24-25, 2019. In addition, the event will feature 9 plenary meetings on economic and societal challenges facing health innovation

Paris, April 4<sup>th</sup>, 2019 – The first edition of HealthTech Investor Day (HTID®), an international event organized with the support of the European health innovation ecosystem, under the High Patronage of Mr. Emmanuel MACRON, President of the French Republic, will take place on June 24 and 25 in Paris, France, at The Peninsula Paris. The event will bring together the most promising European HealthTech companies (biotech, medtech and e-health), leading pharmaceutical companies and international investors specializing in health innovation.
